## 4. FIRST AID MEASURES

# Description of first aid measures General advice:

## Indication of any immediate medical attention and special treatment needed

**Notes to physician:** If burn is present, treat as any thermal burn, after decontamination. If lavage is performed, suggest endotracheal and/or esophageal control. Danger from lung aspiration must be weighed against toxicity when considering emptying the stomach. No specific antidote. Treatment of exposure should be directed at the control of symptoms and the clinical condition of the patient.

## Advice for firefighters

## 7. HANDLING AND STORAGE

**Precautions for safe handling:** Avoid breathing process fumes. Do not breathe dust. Minimize dust generation and accumulation. Keep container closed when not in use. Keep away from heat and

sources of ignition. Take precautionary measures against static discharges. Use with adequate ventilation. Take care to prevent spills, waste and minimize release to the environment.
